Approvals according to obsolete works standards M 3275, M 3575, M 3271-1 and M 3477

Dear Sir or Madam,

In June 2020, MAN Truck & Bus SE decided to stop new approvals of engine oils according to works standard M 3271-1 and M 3477. Therefore, it will not be possible to apply for new approvals from 01.07.2020 onwards.

We will not prolong expired and previously valid approvals according to withdrawn MAN works standard M 3275, M 3575, M 3271-1 and M 3477 anymore. But it will still be possible to claim for these former approvals "meets M 3275" or "meets M 3477" etc. instead of "approved".

This acceptance will also cover formerly approved M 3275, M 3575, M 3477 formulations if changes of the formulation are made according to the ATIEL Code of Practice read across guidelines. Additive companies are allowed to inform their customers by a written confirmation about the possibility to use the "meets" claim.

If a formulation no longer meets the requirements of the MAN specifications M 3275, M 3575, M 3271-1 and M 3477, the owner of the original approval and the owner of the reblend or rebrand approval have to ensure that the "meets" claim will be removed immediately.

The manufacturer or supplier must apply for an extension of the approval in writing. The application must contain confirmation that the formulation is unchanged. In the case of rebrands a written declaration of consent from the previous supplier must be submitted as well.

If the extension is not applied for in good time within the approval period (at least two months prior to expiry of the approval) all reblend approvals and all related rebrands will be deleted from the publicly service product database on the day of expiry of the approval. After expiry of the approval period the product approval can be continued only by way of a new approval procedure, for which a charge will be made.
